

General Information for Breeding to Dual N Time

Breeding Fees will be \$1250.00 for the 2024 Breeding Season. The breeding fee is broken down to the following:

Booking Fee: \$150.00 Booking – Non Refundable

Breeding Fees for 2024: Stallion Breeding Fee \$1100.00 (Does not include shipping) Total

Stud Fee for 2024: \$1250

Mare Care, AI, shipping, and other fees related to the mare are additional to the total breeding fees and are the responsibility of the mare owner. Please contact Tiffany Rives (307-217-0409) with payment information for shipping and shipping address no later than one day prior to collection/shipping date.

Special consideration may be made for multiple (3+) mares from the same owner and for mares who are proven producers/performers. Total Stud Fee is to be paid in full prior to semen being shipped.

The Mare Owner understands that the stallion will be available for collection during the months of February through July barring any unforeseen circumstances. Collection Days are Monday, Wednesday and Friday (Tuesday and Thursday upon consideration but not guaranteed). Mare Owner or his/her agent must notify the Stallion Owner NO LATER THAN NOON (mountain daylight time) THE DAY PRIOR TO THE DATE WHEN SEMEN IS REQUIRED TO BE COLLECTED AND SHIPPED (2 DAYS PRIOR TO BREEDING).

2. Be sure you complete the Mare Information/Mare Owner/Shipping form 3. Enclose copy of Mare's papers
4. Ensure that the booking fee has been paid to ensure a spot is available for your mare. Remaining breeding fee must be paid before semen is collected for fresh AI or shipping of semen. Stallion will not be collected without payment in full for the breeding fees and contract signed.

Once Dual N Time Partners has accepted and executed the Breeding Contract, a copy will be returned to you.

To Dual N Time - AQHA# 5111194, during the 2024 breeding season, via Shipped Fresh cooled semen or onsite fresh semen. Mare owner will pay Dual N Time Partners the agreed breeding fee of \$1000.

This agreement is subject to the following conditions: The nonrefundable booking fee of \$150.00 is due with this contract. The balance of \$1100.00 (includes collection fee for first shipment only) must be paid for before any semen will be shipped. All shipping fees/costs will be the responsibility of the mare owner. Shipping fee includes shipment of semen via next day air delivery on FedEx or UPS. **A \$250 collection fee and shipping cost is due payable for each subsequent collection needed after the first shipment.**

Live Foal guarantee: If the mare fails to conceive during the 2024 breeding season, the Mare Owner may breed the same mare in the following year at cost of collection and shipping. If a mare fails to conceive and cannot be used the following year, a different mare may be substituted upon approval. Once a mare conceives, if the resulting foal is stillborn or dies before standing and nursing, the mare owner may return the same mare or a different mare upon approval to be rebred the following year only. This guarantee will apply only if notification of the foal's death plus the breeding certificate issued by the Stallion Owner is sent to the Stallion Owner by registered mail within 48 hours of the foal's death. Statements by a licensed veterinarian of the details of the foal's death must follow within 10 days or the Live Foal Guarantee becomes null and void.

The live foal guarantee is expressly contingent upon the mare owner properly caring for the pregnant mare. Proper care shall include, but shall not necessarily be limited to, proper feeding and nutrition, regular deworming with products approved for pregnant mares, vaccinations that are customary in the mare owner's geographical area, and proper intervention during foaling if necessary. The Mare Owner will be issued a valid breeding certificate for the AQHA by the Stallion Owner when the mare is checked in foal, all paperwork has been returned, and all fees and/or expenses have been paid. A replacement fee of \$25.00 will be charged if the Mare Owner loses a breeding certificate.

The Mare Owner understands that the stallion is guaranteed to be available for collection, barring any unforeseeable circumstance, on Monday, Wednesday and Friday. Tuesday and Thursday may be considered not guaranteed. Mare Owner or his/her agent must notify the Stallion Owner no later than noon (mountain time) the day before the date when a semen specimen is required to be collected and shipped (2 days prior to breeding). For the purpose of this contract, the term "breeding season" shall be defined as the period from February 1, 2024 to July 31, 2024 at which time all breeding will be discontinued until the following season.

This contract is not assignable or transferable without written consent. A copy of the mare's registration papers must be included with this contract. When the mare owner signs and returns this contract (and it is signed by a member of Dual N Time Partners), it becomes a binding contract on both parties, subject to the above terms and conditions. The mare owner irrevocably agrees that his/her sole recourse against members of Dual N Time Partners with respect to the performance or non-performance of this contract is return of the stallion service fee, less the booking fee. Stallion services fees are not refunded unless the stallion dies or becomes unfit for service. In that eventuality, the mare owner may choose a refund of the service fee. The terms of this contract shall be governed by the laws of the State of Wyoming.
